This event is organized within the MSCA4UKRAINE project "Solidarity as Responsible Business Conduct: beyond Corporate Respect for Human Rights", funded by the European Union.





This year, the Panel Discussion on Business and Human Rights presents a national dialogue on the concept of responsible business conduct in the process of Ukraine's post-war recovery. Civil society organizations of Ukraine, business associations, professional unions, academic community are invited to participate.

The main goal is to involve civil society in discussing how responsible business conduct how to ensure responsible business conduct, what are the gaps and barriers, what can be the role of civil society organizations in ensuring responsible business conduct.

The discussion will be built around <u>an open call to recover Ukraine on the basis of responsible business</u> conduct.

We invite all Forum's participants to sign the statement!

Attention will also be paid to the tools that civil society can use to ensure responsible business conduct.

We will also discuss:

- the latest business and human rights developments, including the draft EU Corporate Sustainability Due Diligence Directive
- how corporate responsibility to respect for human rights correlates with sanctions (what is the role of civil society organizations and business associations here)
- the 2023 edition of the OECD Guidelines for Multinational Enterprises on Responsible Business Conduct
- how the OECD sees the role of civil society organisations and business associations in the recovery process of Ukraine.

Based on the results of the event, we plan to prepare the brochure "Responsible business conduct for the recovery of Ukraine: the vision of civil society" and distribute it among international and national partners in two languages — Ukrainian and English.
